This endorsement does not exclude coverage under Section I - Extensions of Coverage, Loss of use for:

1. Loss of rents; or
2. Additional living expense for a secondary residence.

Secondary residence means a private residence occupied by the named **insured** for less than a total of 180 days in the most recent calendar year or a private residence not principally occupied by the named **insured**.
